## ANNOUNCEMENT

Further to the announcement of CK Life Sciences Int'l., (Holdings) Inc. dated 7 July 2002, the Company filed a writ of summons with the court on 8 July 2002.

CK Life Sciences Int'l., (Holdings) Inc. (the “Company”) has noted certain allegations made on 6 July 2002 by Te Yuen Chun (also known as Alice Te), an officer of a company called GP Holdings (International) Limited (“GP Holdings”) about the intellectual property and the products of the Company and its subsidiaries (together, the “Group”), including an allegation that their intellectual property rights had been infringed by products developed by the Group. In response to those allegations, the Company issued an announcement dated 7 July 2002 as follows:-

“CK Life Sciences Int'l., (Holdings) Inc. (the “Company”) noted certain reports in the press on 7 July 2002 about allegations made by a company called GP Holdings regarding the Company’s products.

The Company wishes to state that:

1. The products introduced by the Company are distinct from the products of GP Holdings as described in their website.
2. The products introduced by the Company do not infringe the intellectual property rights alleged by GP Holdings.

In relation to all unfounded claims and allegations against the Company and its products, the Company reserves the right to take all necessary actions to protect its interests.”

The Company remains of the view stated in the announcement, and believes that the relevant allegations made by or on behalf of GP Holdings are unfounded. Further, the Company has filed a writ of summons in the Court of First Instance of the High Court of Hong Kong on 8 July 2002 as plaintiff against GP Holdings and Te Yuen Chun, seeking injunctive relief, damages and costs. The final outcome of the court proceedings cannot be predicted with certainty at this stage.
