

**CK Life Sciences Int'l. (Holdings) Inc.**  
**Online User Guide for the Annual General Meeting**  
**on 13th May, 2021**

The Annual General Meeting (“AGM”) will be a hybrid meeting. In addition to the traditional physical attendance at the AGM, shareholders of CK Life Sciences Int'l. (Holdings) Inc. (“Company”) (“Shareholders”) have the option of attending, participating and voting at the AGM through online access by visiting the website at <https://web.lumiagm.com> (“Online Platform”).





The Online Platform will be open for registered Shareholders and non-registered Shareholders to log in approximately 30 minutes prior to the commencement of the AGM and can be accessed from any location with internet connection by a smart phone, tablet device or computer. Please refer to the Company’s notification letter to Shareholders dated 13th April, 2021 for login details and arrangements. If Shareholders have any questions regarding the login details and AGM arrangements in general, please contact the hotline of Computershare Hong Kong Investor Services Limited (“Computershare”), the Company’s Branch Share Registrar at (852) 2862 8558.

Below are some pointers in relation to the use of the Online Platform. If Shareholders experience any technical difficulties or require assistance while using the Online Platform, please call Computershare at (852) 2862 8558 from 9:00am to 5:00pm (Hong Kong Time) on the date of the AGM. Kindly note that the hotline cannot record your vote(s) over the telephone.

**Some pointers:**

1. You will need a reliable Internet connection fast and stable enough to support video streaming (for example, as if you are watching a YouTube video).
2. However, unlike YouTube, if your Internet connection is not fast or stable enough to support video streaming or keep pace with the AGM proceedings, part or parts of the AGM online broadcast may be lost or skipped. You will not receive the broadcast on a delayed basis and may miss part or parts of the AGM proceedings (including voting).
3. If your Internet connection is unstable, inadequate or interrupted, your attendance at the AGM may be interrupted and you may be unable to vote or ask questions. This will not affect the AGM itself which will continue and will remain valid and effective.
4. If your Internet connection is restored, you might be able to rejoin the AGM online but you may have missed part or parts of the AGM proceedings (including voting) which will not be repeated.
5. Each set of shareholder login details can only be used on one device (for example, smart phone, tablet device or computer) at a time, and cannot be shared with others.

The online AGM is technology-dependent and the above are some of the possible risks with respect to an online meeting. To ensure your right to vote is exercised, you are encouraged to appoint the Chairman of the AGM as your proxy. Alternatively, you can choose to appoint another person as your proxy or attend the AGM in person provided you are allocated access to attend in person in accordance with the prior online registration and balloting arrangements as set out in the Company’s circular dated 13th April, 2021.

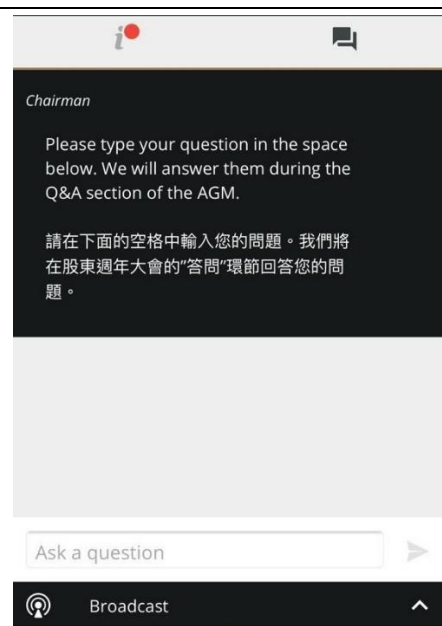

5. When the poll is open, a list of all the resolutions and voting choices will be displayed. Scroll through the list to view the resolutions.

**Please enter your vote(s) as soon as possible when you see the resolution(s).** To vote on a resolution, click on one of the voting options (“For” or “Against”). Your vote will be highlighted and a confirmation message will appear.

To change your vote, simply tap a different option to override. To cancel your vote, tap “Cancel”. The final option you tap before the voting closes shall be your final vote for all the resolutions.



6. If you would like to pose a question during the AGM, click on the “message” button at the bottom of the page. You can submit your question in the text box. Your question will only be seen by the Company’s representatives but not other attendees in the AGM.
